

Financial Report

In 2012 Mountain Lamp continued to thrive thanks to your financial contributions and to income from a growing number of retreats. Our total unrestricted income was \$91,394. Sixty percent came from contributions and 37 percent from retreats. We also received \$2,700 in restricted donations to the Jizo Remembrance Grove and the Bell Fund.

Total expenses were \$63,671. Fortyseven percent was for buildings and property; 26 percent for office, communications, and program support; and 19 percent for expenses related to retreats.

We ended the year with net ordinary income of \$27,723 and current assets of \$127,294, including \$3,425 designated for Bell Fund.
