Mountain Lamp is a rural practice center in the Pacific Northwest dedicated to cultivating the ground already tilled by Thich Nhat Hanh and Robert Aitken in the mindfulness and Zen traditions. The lay practice center provides a daily schedule of sitting, walking, and work meditation for residents and guests. The resident teachers, Eileen Kiera and Jack Duffy, carry on the teachings of their primary teachers Thich Nhat Hanh and Robert Aitken Roshi. Throughout the year they lead Zen and mindfulness retreats, as well as retreats that reflect a blend of the two traditions. In the spring, Mountain Lamp offers a three-week study and meditation retreat to deepen our understanding and knowledge of Buddhist tradition and teachings.


Mountain Lamp's 115 acres of hilled forest, pasture, and lake are home to bear, bobcat, coyote, and elk along with a variety of songbirds, waterfowl, and raptors. The practice center is dedicated to being a home to those beings who have traditionally lived here and to lay practitioners of the Dharma for generations to come.

Financial Report

Last year practice at Mountain Lamp continued to thrive thanks to financial contributions and the energy and presence of both new and longterm practitioners. Our total income was \$100,652, of which 49% came from retreats and 48% from contributions. Retreat income increased 47% compared to 2012 due to many friends joining the resident community for personal retreats, and greater attendance at many of our well-established group retreats.

Total expenses were \$68,977. Our major spending categories were 46% for the buildings & property, 26% for office & program support, 14% for retreats, and 13% for site upgrades and maintenance.

We ended the year with net income of \$31,675. Our current assets are \$158,144, of which \$4,483 is set aside for the Bell Fund.
